Current Events:

A Township Resident attended the February 15th Board Meeting to express concerns regarding the roundabout slated to be constructed at Abbotsford Rd. and Lapeer Rd. beginning this Spring as it will likely lower property values of the nearest houses due to the increase in noise from vehicles including the gravel trains that travel Lapeer Rd. Roundabouts are being built in more areas due to State and Federal funding. It is not known if the closest property owners receive any compensation.

The State announced it will pay for the spraying of Gypsy Moths in St. Clair County. Clyde Township had the highest percentage of moth infestation in 2021 and the State's intervention will save Clyde Township Residents from having to pay out of pocket. Residents will still need to sign up to have their property sprayed.
